

# PENINSULA CYCLE CLUB ("PEN CC")

## MEMBERSHIP APPLICATION/RENEWAL

In consideration of the acceptance of my membership, I hereby freely agree to and make the following contractual representations and agreements.

I fully realize the dangers of participating in bicycle riding, racing, and training and fully assume the risks associated with such participation including, by way of example, and not limitation, the following: The dangers of collision with pedestrians, vehicles, other bicycle riders, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, and weather conditions; and the possibility of serious physical and/or mental trauma or injury associated with athletic bicycle riding, racing or training.

I hereby waive, release and discharge for myself, my heirs, executors, administrators, legal representatives, assigns, and successors in interest (hereinafter collectively "successors") any and all rights and claims which I have or may hereafter accrue to me against the officers, members, and sponsors of Pen CC, property owners, law enforcement agencies, all public entities, special districts, and properties (and their respective agents, officials, and employees) through or by which any events will be held for any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of my participation in or association with the riding, racing or training.

I agree it is my sole responsibility to be familiar with the ride or race course, and Pen CC rules and all laws pertaining to riding on public roads. I understand and agree that situations may arise during a ride or race which may be beyond the immediate control of the club officials or organizers, and I must continually ride so as to neither endanger myself nor others. I accept responsibility for the condition and adequacy of the bike and equipment I use. I will ride wearing a helmet which satisfies the requirements of USA Cycling rules and that can protect against serious head injury, and assume all responsibility and liability for the selection of such a helmet. I have no physical or medical condition which to my knowledge, would endanger myself or others if I participate in bicycle riding or racing, or would interfere in my ability to bicycle ride or race.

I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to any other provision herein, or as a consent to any subsequent waiver or modification.
